Deputy Chair Shappell called the meeting to order at 9:04 am.

**Minutes - On the motion of Comm. Buehler, seconded by Comm. Marshall, the Board approved the minutes from the June 25, 2019 and July 9, 2019 meetings, upon the unanimous vote among the members present in favor of the motion, it was carried 4-0.**

**Cemetery Care** – Deputy Chair Shappell said that she is not sure who is working this year and commented that DPW Foreman Dave Short has been approached by Chairman Gray about the state of the cemetery. Trustee Zapata said that the Village Board needs to be notified if the cemetery is shorthanded and if there is need for extra help. It would be best for the Cemetery Board to recommend it. She suggested hiring help in April to get ahead. Comm. Murphy agreed with an April hire, and commented that she normally hires for the parks in March and April. Comm. Buehler said it would be a good idea to suggest to the Village Board that hiring for the cemetery needs to be done sooner. Deputy Chair Shappell said that the cemetery looks better now than it did.

**Cemetery Administrator** – Mr. Batlle said that section 11B looked the worst while he was trying to show lots. He stated that all family lots along the road in 11B are sold.

**A Village Minute** – Trustee Zapata said that the waterline project continues. East Street will continue to be worked on until the Spring due to the sewer replacement needed. Griffin and Hannum are currently having sidewalks replaced. She said that Dick Perkins will be leading the sidewalk installation on W. Elizabeth.
