

INSTRUCTIONS FOR AN APPLICATION FOR A
CERTIFICATE OF OCCUPANCY

Please print throughout application and submit to the Code Enforcement Officer.

Submit the appropriate application fee: **\$50.00**

Attach to this application a final (as-built) survey by a licensed surveyor. No survey is required if work does not involve a new building, structure or changes to the size (area) of the existing building or structure. Include with this application any other certifications and information requested by the Code Enforcement Officer.

{When Required} (Section 225-73, Village Zoning Law) No building or structure hereafter erected, constructed, enlarged, altered or moved and enlarged, extended, altered, or relocated portion of an existing building or structure hereafter completed shall be occupied or used until a Certificate of Occupancy has been issued by the Code Enforcement Officer.

A Certificate of Occupancy shall be applied for before the work has started under the Building Permit to allow for the Code Enforcement Officer opportunities for construction stage inspections. Otherwise, the request for a Certificate of Occupancy may be denied. The Certificate of Occupancy shall be issued by the Code Enforcement Officer after an inspection of the premises and a determination that the applicant has complied with the provisions of the Building Permit.

No Certificate of Occupancy is required for any alteration or ordinary repairs to an existing structure which was not structural in nature.

The Certificate of Occupancy is only for the areas involved in the Building Permit, and not for any other portions of the building or structure.

No approval given under the provisions of the Zoning Law of the Village of Skaneateles shall become final unless and until confirmed by the issuance of a Certificate of Occupancy.
