At 7:04 pm, Chairman Hartnett called for the discussion of annual licensing for sidewalk cafe operations. Attorney Galbato introduced the discussion by noting that annual licensing is required under Village Code.

Chairman Hartnett called the Hidden Fish application. There were no questions from the Board.

Chairman Hartnett, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Hidden Fish at 7 Fennell Street." Member Komanecky seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Patisserie application. There were no questions from the Board. Member Brace, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Patisserie at 2 Hannum Street. The existing permanently installed railing is grandfathered." Member Komanecky seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Gilda's application. There were no questions from the Board. Member Giannino, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Gilda's at 12 West Genesee Street." Member Brace seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Sherwood Inn application. Member Komanecky stated that it was her understanding that the shrubbery border was required by the NYS Liquor Authority rules. Chairman Hartnett, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Sherwood Inn at 26 West Genesee Street." Member Komanecky seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Doug's Fish Fry application. There were no questions from the Board. Member Giannino, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Doug's Fish Fry at 8 Jordan Street." Chairman Hartnett seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Moro's Kitchen application. Mr. Carroll stated that Mr. Moro had amended his application and provided an image of a conforming railing that will be installed in place of the white fencing that has been used in prior years. Chairman Hartnett, "I move that the Planning Board grants the 2024 annual permit for sidewalk café to Moro's Kitchen at 28 Jordan Street based on its revised application." Member Brace seconded the motion. Upon the unanimous vote of the members in favor of the motion, the motion was carried 4-0.

Chairman Hartnett called the Vermont Green Mountain application. Mr. Carroll informed the Board that the application is incomplete. Mr. Eggleston and Ms. Jones requested that the matter be continued. Chairman Hartnett said that this matter will be administratively continued to the Board's next meeting.
