
- State assistance for rural communities:

### STATE ASSISTANCE FOR RURAL COMMUNITIES



### INCREASE SUPPORT FOR THOSE SERVING THEIR COMMUNITY



Provide a state income tax credit of \$2,500 for volunteer firefighters and members of a volunteer ambulance corps (A.2654, Angelino).



Create a \$1,500 wage tax credit for employers hiring New York National Guard men and women, reservists, volunteer firefighters, and EMS Personnel (A.2044, Hawley).



Create the New York State Volunteer Fire Protection Emergency Reimbursement Account to reimburse volunteer departments and Emergency Medical Services for PPE **(A.4761, Norris)**.



Allow volunteer firefighters to attend training without being penalized by their employer; and create tax incentives for employing volunteer firefighters (A.2267, Norris).

#### CONNECTING RURAL RESOURCES TO REDUCE POVERTY

Enact the NY Food Insecurity, Farm Resiliency, and Rural Poverty Initiative:

- Establishes the Permanent Agricultural Purchasing Assistance Program to provide \$10 million in annual funding for food banks to purchase agricultural food products from New York farmers. During times of declared state of emergency, the annual funding will increase to \$20 million.
- Creates the Meat, Fiber and Dairy Processing Incentive Program to increase the available processing capacity for meat, fiber, and dairy products in New York.
- Creates the Personal Service Cost Assistance Program to provide \$2 million annually to offset increased hiring costs for expanded food bank operations.
- Establishes funding for a number of programs designed to assist New York farmers:
  - Beginning Farmers Grant Program;
  - Farm Infrastructure & Equipment Grant Program;
  - o Commercial Real Estate & Warehousing Grant Program;
  - Cold Storage Equipment Grant Program;
  - Cold Storage Transportation Grant Program;
  - o Transportation Fuel Reimbursement;
  - o FarmNet Program.
- Establishes the Hunger Prevention and Nutrition Assistance Program to award contracts to non-profit organizations: City Harvest, Inc. and Island Harvest, Ltd.
- Increases the tax credit allowed to qualified farmers for donating food to any eligible food pantry from 25% to 50% of the fair market value.
- Increases the value of the estate livestock exemption.
- Repeals the Farm Labor Laws signed into law in 2019.
- Provides a \$35.7 million appropriation to the Department of Agriculture & Markets to fund the Initiative (A.5708, Tague).

### RURAL SCHOOL TRANSPORTATION



Allows local Boards of Education to expand Parent Contracts (as authorized in Subdivision 27 of Section 1709 of Education Law) so schools can contract with an approved network of parents, family members, neighbors, and teachers for the purpose of providing pupil transportation and reducing reliance on zero-emission school buses (To be introduced, Smullen).

#### EXPAND ACCESS TO BROADBAND AND INCREASE CELL COVERAGE



Decentralize the current broadband expansion process by allowing localities to work together and design regionally-based plans to ensure internet access to every rural citizen (A.4686, Smullen).



Design a new incentive program to encourage those who work remotely, and businesses who offer remote work options, to live or have their headquarters based in Rural areas of New York State (needs to be introduced).



Create the Rural Mobile Communications Fund to provide grant opportunities for increasing cellular coverage in rural areas subjected to dropped coverage (needs to be introduced).

# CLIMATE LEADERSHIP AND COMMUNITY PROTECTION ACT RURAL CHOICE



Allow counties to opt-out of the requirements of the CLCPA (To be introduced, Tague).

### INTERREGIONAL ENROLLMENT IN SCHOOLS





Establish the "EmpowerED" Act to provide opportunities for students to cross-enroll in classes offered by local schools outside of their home district, and by expanding BOCES services (To be introduced, Smullen).
