<u>Minutes</u> – **Resolution #2023-328:** On the motion of Trustee Evans, seconded by Trustee Lynn, it was resolved and unanimously carried (4-0 in favor) to approve the Regular Meeting Minutes of November 9, 2023, as presented.

<u>Correspondence & Announcements</u> – Mayor Sennett noted the following:

- Receipt of invite from the Office of Assemblyman John Lemondes for a Rural Equity Forum.
- Receipt of announcement for planning and zoning webinars offered by NYCOM in November and December.
- Receipt of email from the Dept of Public Service regarding available general information about helping consumers lower their energy bills.
- Receipt of email regarding the State and Local Fiscal Recover Funds (ARPA money) and a new "interim final rule" (also known as the Obligation IFR).
- Receipt of email from Thomas Billone regarding the gazebo bathrooms.
- Receipt of email from Kendra Masoud asking if a new cell phone tower would be going up in the Village.

New Business

Consider approving the Cyber Security Citizens' Notification Policy.

Resolution #2023-329: On the motion of Trustee Lynn, seconded by Trustee Evans, it was resolved and unanimously carried (4-0 in favor) to approve the Cyber Security Citizens' Notification Policy.

Authorize Mayor Sennett to sign the Inter-Municipal Agreement Regarding Justice Court Security Personnel as Authorized by Article 5G of the General Municipal Law of the State of New York.

The Town approached us about our officers covering the security detail at the court.

Resolution #2023-330: On the motion of Trustee Evans, seconded by Trustee Richards, it was resolved and unanimously carried (4-0 in favor) to authorize Mayor Sennett to sign the Inter-Municipal Agreement Regarding Justice Court Security Personnel as Authorized by Article 5G of the General Municipal Law of the State of New York.

Consider sending DMO Posella, DDMO Pagano, and Laborer Kieffer to the APWA conference on March 21-24, 2024 for \$810 to be paid out of A1490.4 (DMO Misc).

APWA is the American Public Works Association. This session is educational and will expose Laborer Kieffer to a lot of relevant municipal information.

Consider awarding the contract for construction material testing associated with the Clift Park Seawall Cap Replacement Project to Kenney Geotechnical Services, PLLC for the not-to-exceed amount of \$3,500.

Resolution #2023-332: On the motion of Trustee Evans, seconded by Trustee Richards, it was resolved and unanimously carried (4-0 in favor) to authorize the Mayor to sign a contract with Kenney Geotechnical Services, PLLC for the not to exceed amount of \$3,500 associated with construction material testing for the Clift Park Seawall Cap Replacement Project.

Consider Civic Plus Planning software for an initial cost of \$10,500 and a year 2 cost of \$8.820.00.

Ian Carroll introduced a variety of software options to the codes office to consider in anticipation of electronic record keeping, cataloging, archiving, and improved workflow processes.

Public Comment – Mayor Sennett asked for public comment:

DMO Posella said that his DPW workers have been out there for a month picking up leaves, every single day, and including today when it was freezing rain all day. The DPW workers have found dog feces mixed in with the leaves. The weather today is the worst you can experience if you work outdoors and these men are out there facing the elements, picking up leaves and now getting dog feces on themselves. This is unacceptable.
