A LOCAL LAW TO AMEND

CHAPTER 225 ("ZONING"), ARTICLE VII ("SUPPLEMENTARY REGULATIONS"), SECTION 225-28 ("GASOLINE PUMPS AND STORAGE TANKS; MINIMUM STREET FRONTAGE; SIDEWALKS; ANIMALS")

OF THE VILLAGE OF SKANEATELES

BE IT ENACTED BY THE VILLAGE BOARD OF THE VILLAGE OF SKANEATELES:

Statement of Intent and Findings.

The Board of Trustees has determined that it is necessary to modify a provision of the Village Code relating to minimum street frontage.

Authority.

This Local Law is enacted pursuant to the authority of the Municipal Home Rule Law, Section 10 and the New York State Village Law Article 7.

Text of Proposed Local Law.

Chapter 225 ("Zoning"), Article VII ("Supplementary Regulations"), Section 225-28 ("Gasoline Pumps and Storage Tanks; Minimum Street Frontage; Sidewalks; Animals"), is hereby amended to read as follows (changes highlighted):

§ 225-28. Gasoline Pumps and Storage Tanks; Minimum Street Frontage; Sidewalks; Animals.

"B. Minimum street frontage. No building or structure shall be built on any lot in a Residential A District that does not have a frontage of at least 50 feet measured along the street line on a legally dedicated street unless approved by the Board of Trustees Planning Board."
